**Title:** Reminder for the OPs on the compliance with ITU-R procedures as it relates to Revision 3 of Recommendation ITU-R M.1457

In previous correspondence with ITU-R WP 8F (refer to PCG8\_27), 3GPP TSG RAN expressed the intention to update Recommendation ITU-R M.1457 in year 2002 (i.e., Revision 3 of Rec. ITU-R M.1457) in order to align Sections 5.1.2 & 5.3.2 (references to SDOs' Standards) to the most up to date material, without any modification to the Overview parts (Sections 5.1.1 & 5.3.1), and still within the scope of the current Global Core Specifications (GCS) (as submitted at the end of year 2001).

Each OPs participating in 3GPP has therefore to submit to ITU the updated references for Section 5.1.2 and 5.3.2 by 1<sup>st</sup> April 2003. The relevant template will be provided by TSG RAN#18 (it will be basically identical to the one provided after TSG RAN#13, i.e., the template used for the submission relevant for Revision 2 of Rec. ITU-R M.1457 by 31<sup>st</sup> May 2002, but format and styles have been revisited according to ITU rules): the tables in the template have to be filled in referring to the most up to date transposed Deliverables (Doc Number, Version, Status, Issued date, and Location). *Therefore, OPs have to jointly decide which version of the 3GPP Technical Specifications will be considered for this transposition purposes.*

In addition, as per previous ITU submission, each OP participating in 3GPP has to submit to ITU the required certifications of references and transposition (i.e., the certification that the standards incorporated by reference into the revised and to-be-published Recommendation ITU-R M.1457 correspond to the set of specifications agreed by the SDOs to be transposed into standards, as well as the certification that the standards are consistent with the relevant Section 5.x.1 of Recommendation ITU-R M.1457 and the Global Core Specification as presented by WP 8F to SG 8).

In summary, the action to be undertaken by each OP participating in 3GPP by 1<sup>st</sup> April 2003 are:

- Update of Sections 5.1.2 and 5.3.2 finalized (transposition of 3GPP Specifications into Standards completed): template that that will be provided by TSG RAN#18 with tables filled in (Doc Number, Version, Status, Issued date, and Location).

- SDOs formally certify to the ITU that their standards incorporated by reference into the revised and published Recommendation ITU-R M.1457 correspond to the set of specifications agreed by the SDOs to be transposed into standards. **The template for this certification is attached as Annex A.**
- SDOs should also certify that their standards are consistent with the relevant Section 5.x.1 of Recommendation ITU-R M.1457 and the GCS as presented by WP 8F to SG 8. The process of transposition of those jointly agreed specifications into the SDOs standards, should maintain close consistency with the jointly agreed specifications. **The template for this certification is attached as Annex B.**
