At the last meeting of ITU-R WP8F (Berlin, 16-23 June) the 'Update Submission' (approved by RAN#24 as RP-040246) and the 'Updated information on the Roadmap' (RP-040220) were processed very smoothly. A short report of the main outcome of ITU-R WP8F#12 in Berlin relevant for TSG RAN activity can be found in Annex 1.

In line with the procedure approved by RAN#22 (RP-030656 - relevant time schedule attached as Annex 2 for convenience), ITU-R Ad Hoc was able to draft all input contributions for the Final submission toward Revision 5 of Recommendation ITU-R M.1457. All docs are submitted to RAN for approval and subsequent submission to ITU-R WP 8F via Individual Members, as usual (deadline for input contribution: October, 1<sup>st</sup>). In particular, the following docs are submitted to RAN Plenary for approval:

- RP-040308 – Overall Final submission toward Revision 5 of Rec. M.1457 (in order to ensure an easier handling of the contributions, the revised Overviews in Sections 5.1.1 & 5.3.1, and the revised list of Specs in Sections 5.1.2 & 5.3.2 are submitted as separate docs);
- RP-040309 – Update of Section 5.1.1 of Rec. M.1457 (Overview);
- RP-040310 – Update of Section 5.1.2 of Rec. M.1457 (list of Specs - titles and synopsis);
- RP-040311 – Update of Section 5.3.1 of Rec. M.1457 (Overview);
- RP-040312 – Update of Section 5.3.2 of Rec. M.1457 (list of Specs - titles and synopsis);
- RP-040313 – Draft accompanying letter for the submission of the updated Global Core Specifications (GCS that has to be prepared by 3GPP Secretary based on the outcome of the current TSGs Plenaries).

In addition the following doc was prepared by ITU-R Ad Hoc:

- RP-040314 – Draft reminder for the OPs on the compliance with ITU-R procedures as it relates to Revision 5 of Recommendation ITU-R M.1457 (the first action required by OPs is the submission to ITU-R of the Letters of Conveyance by October, 1<sup>st</sup>);

## ANNEX 1

With reference to Revision 5 of M.1457 (M.1457-5), the received contributions were processed quite smoothly and no problems are expected for the approval of M.1457-5 scheduled for the next meeting of ITU-R WP 8F (Shanghai, 13-20 October 2004).

Several contributions were received on the preliminary draft new Report on the impact of Software Defined Radio on IMT-2000, the future development of IMT-2000, and systems beyond IMT-2000 and the document has been progressed. Several input documents were also received on the preliminary draft new Report on Radio Aspects for IMT-2000 and systems beyond IMT-2000: progress was made in areas of definition, frequency aspects and impacts, and in defining environments. This work is critical to the development of spectrum needs.
