## 1 Opening of Meeting and Chairman's Remarks

Mr.Chatterjee (Chairman and Committee T1) opened the meeting and welcomed the participants to San Francisco. The list of participants is given at **Annex E**.

## 2 Approval of Agenda

The draft Agenda for the meeting was discussed and approved with some minor amendments. The approved Agenda is given at **Annex A [3GPP/OP#4(00)1r1]**.

## 3 Approval of Report of OP#3

The draft report of OP#3, which had been revised to take account of comments received, was presented and approved **[3GPP/OP#3(00)45r1]**.

**Decision OP4/1:** Report of OP#3 approved **[3GPP/OP#3(00)45r1]**.

### 3.1 Actions arising

The status of the actions arising from OP#3 were reviewed **[3GPP/OP#4(00)03]**. It was agreed that all actions had either been discharged or had been placed on the Agenda for this meeting.

## 4 Results from PCG#5 and matters arising

Mr Rosenbrock (3GPP PCG Chairman) gave a brief introduction of the results of PCG#5 that had taken place the previous day.

The PCG had processed revised Terms of Reference for TSG T which had been submitted to the Organizational Partners for approval **[3GPP/OP#4(00)07]**. These were approved without further comment.

**Decision OP4/2:** Revised Terms of Reference for TSG T approved **[3GPP/OP#4(00)07]**.

The PCG had processed revised Terms of Reference for TSG CN which had been submitted to the Organizational Partners for approval **[3GPP/OP#4(00)09]**. These were approved without further comment.

**Decision OP4/3:** Revised Terms of Reference for TSG CN approved **[3GPP/OP#4(00)09]**.

## 5 Review of 3GPP Progress

Mr Rosenbrock presented a contribution which emphasised the need for 3GPP specifications to contain a "superset" of requirements from which regional requirements could be selected **[3GPP/OP#4(00)05]**. This reflected the original intention for 3GPP specifications but some concerns had been raised that regional requirements were being specified externally to 3GPP, particularly in the case of RAN specifications. After further discussion the Partners confirmed that wherever possible, additional requirements mandated by regulators should be clearly indicated in the "superset" of 3GPP specifications.

**Decision OP4/4:** The Partners confirmed that wherever possible, additional requirements mandated by regulators should be clearly indicated in the superset of 3GPP specifications. **[3GPP/OP#4(00)05]**.

### 5.1 Y2000 current results

The Partners noted the progress being made in 3GPP based on the work plan that had been discussed during the PCG meeting held the previous day.

## 6 3GPP Funding

Mr Yoshimura, on behalf of Mr Davidson, presented the report of the 3GPP Funding and Finance Group (FFG) [3GPP/OP#4(00)08]. Mr. Scrase presented the detailed Annexes contained within the report.

FFG had predicted that there would be a budget surplus for year 2000 and a discussion had taken place on how this should be managed. This had led to the proposal that the surplus should be returned to the Partners in the form of a credit note towards their contributions expected in year 2001. This approach was approved by the Partners. It was noted however, that there may be additional expenditure required for TTCN work in year 2001, and that this should be taken into account before concluding on the surplus to be returned.

**Decision OP4/5:** The year 2000 budget surplus should be returned to the Partners in the form of a credit note towards their contributions expected in year 2001 [3GPP/OP#4(00)08].

FFG had proposed that the following 3GPP support budget should be approved by the Partners for year 2001

The budget proposal was approved without further comment.

**Decision OP4/6:** 3GPP support budget for year 2001 approved [3GPP/OP#4(00)08].

The following proposed 2001 specific tasks budget was presented and approved taking into account a previous decision that a portion of this funding may be anticipated for use in December 2000.

**Decision OP4/7:** 3GPP specific tasks budget for year 2001 approved [3GPP/OP#4(00)08].

FFG had considered the formula on which the contributions from each Partner are based and discussed a proposal received from CWTS that they should continue to contribute outside of that formula. FFG had noted a proposal from CWTS that they provide a fixed payment of 180 k€ for year 2001. This proposal was agreed by the Partners.

**Decision OP4/8:** The proposal from CWTS that they should contribute 180 k€ to the 3GPP budget for year 2001 agreed by the Partners [3GPP/OP#4(00)08].

Madam Cao also reported that in addition to the financial contribution detailed above, CWTS are considering the provision of a voluntary expert to work within the Mobile Competence Centre. CWTS also confirmed that it was their intention to further increase their contribution to 3GPP for year 2002.

## **7 New Requests for 3GPP Partnership**

The status of the application received from the CDMA Development Group for MRP status in 3GPP was reviewed. Correspondence had been sent to the CDG following the previous OP meeting and an acknowledgement had been received from them indicating that the requisite changes were in the process of being made [3GPP/OP#4(00)06]. Further information had been received from the CDG indicating that their change process was now complete, but this had only arrived on the day of this OP meeting [3GPP/OP#4(00)06]. The Partners felt unable to draw any conclusion during the meeting but agreed to review the CDG website to verify the completeness of the changes that had been made. This review process would be completed by correspondence and the Secretary was requested to inform the CDG of the results in due time.
