As part of the closure of release 4, a decision needs to be made regarding which R99 specifications should be upgraded to be contained in Rel-4. A proposal for this is below and SA1 is asked to comment on the decisions and update or approve this document.

Once approved, the information in this document will be passed to SA #11 after which time the specifications moved to release 4 will be created.

3GPP specifications

Notes:

1. The "virtual number" column indicates a logical order for the specifications. 3G specs in the ranges 21.xxx to 35.xxx and 41.xxx to 45.xxx are mapped onto the equivalent number in the range 01.xxx to 15.xxx. Old format GSM specs are mapped from aa.xx to aa.0xx.
2. A spec number in italic indicates that the preceding specification has been replaced by that shown in italic, which has its own entry in the table.
3. A cell shown in red indicates a specification which it is anticipated will be created for the appropriate Release, but which has not yet been created. The working assumption is that, unless the TSG / WG has indicated to the contrary, any specification which exists for Release N will also exist for Release N+1.
