**1. Overall Description:**

During its meeting R2#33 in Sophia Antipolis, RAN WG2 received a contribution (R2-022837), highlighting a number of RAB combinations considered by many companies as not providing additional test coverage beyond that provided by other RAB combinations already captured in section 6.10.2 of TS34.108v3.9.0. It is recognised that all these RAB combinations are part of the LOW priority test case package as identified by the GCF. Based on this highlighted list, RAN 2 agreed the following RAB combinations that it felt could be considered as providing no additional test coverage benefit, and could be considered as candidates for removal from TS34.108.

RAN WG2 would like to ask TSG RAN and TSG T to consider the enclosed list and determine whether there is any benefit in removing these RAB combinations from TS34.108. These RAB combinations could be either deleted completely or retained in the new RAN WG2 report TR25.993 on RAB/RB examples, depending on the recommendation of TSG RAN and TSG T.

RAN WG2 can co-ordinate with T WG1, depending on the decision of TSG RAN and TSG T, to provide any necessary CRs to TS34.108 and TR25.993 in time for Plenary #19.
