TSG T2 Elections

- **Nicola Vote (NTTDoCoMo) stood for the second position of T2 vice chair unopposed and was elected**

T2 Meetings held since TSG-T#23

- **T2#25 Plenary: 19th – 23rd April 2004**
 - **Venue: Edinburgh, Scotland**
 - **Host: European Friends of 3GPP**

Joint Meetings held since TSG-T#23

- **GUP: 20th April 2004**
 - Joint T2 SWG2 / CN4
 - Venue: Edinburgh, Scotland (co-located T2 and CN4)

Key general issues at T2#25

- 25 delegates attending, approx 98 tdocs processed
- T2 Structure
 - SWG2 and SWG3 were dissolved at the end of the meeting. T2 will now operate as one Plenary but Josef Laumen will still lead the MMS REL- 6 work. Individual SWG mailing lists closed.
- Transfer of MMS to OMA
 - Letter from PCG to OMA identifies that IPR/copyright issues are unresolved
 - T2 Chairman instructed T2 not to spend time on MMS transfer matters until clarification on impact for T2 concerning PCG decision is obtained from TSG T.
- Generic User Profile
 - T2 proposes the transfer of T2 GUP work (TS 23.241, TS 24.241) to CN4 or SA2. CN4 and SA2 have agreed that the specs should go to CN4. This spec transfer has to be formally endorsed by TSG-CN and TSG-T.

SWG2 (UE Interfaces and Capabilities) Summary

Prem Sood (Sharp) chaired the SWG2 session

- **2 LS's agreed.**
 - AT commands for Logical channels: Security concerns
 - GUP: Proposal for transfer of T2 GUP work
- **2 CR's agreed**
 - TS 23.241 Correction of naming of structural main parts
 - TS 27.007 Updating error codes descriptions for UICC support

SWG3 Summary (MMS)

Josef Laumen (Infineon) chaired the SWG3 session

- **2 LS's agreed**
 - **MM4 Unbundling**
 - **Resolution of SIP based addressing**
- **6 CR's TS 23.140 agreed (5 REL-6, 1 REL- 5 companion CR)**
 - **REL-5 CR's:**
 - **Correction to erroneous OMA reference**
 - **REL-6 CR's:**
 - **Correction to erroneous OMA reference**
 - **MM4 Addition of Recipient list**
 - **Correction to erroneous mapping Annex 1**
 - **MM size indication to MMS UA**
 - **MM7 delivery conditions**

SWG3 Ongoing matters

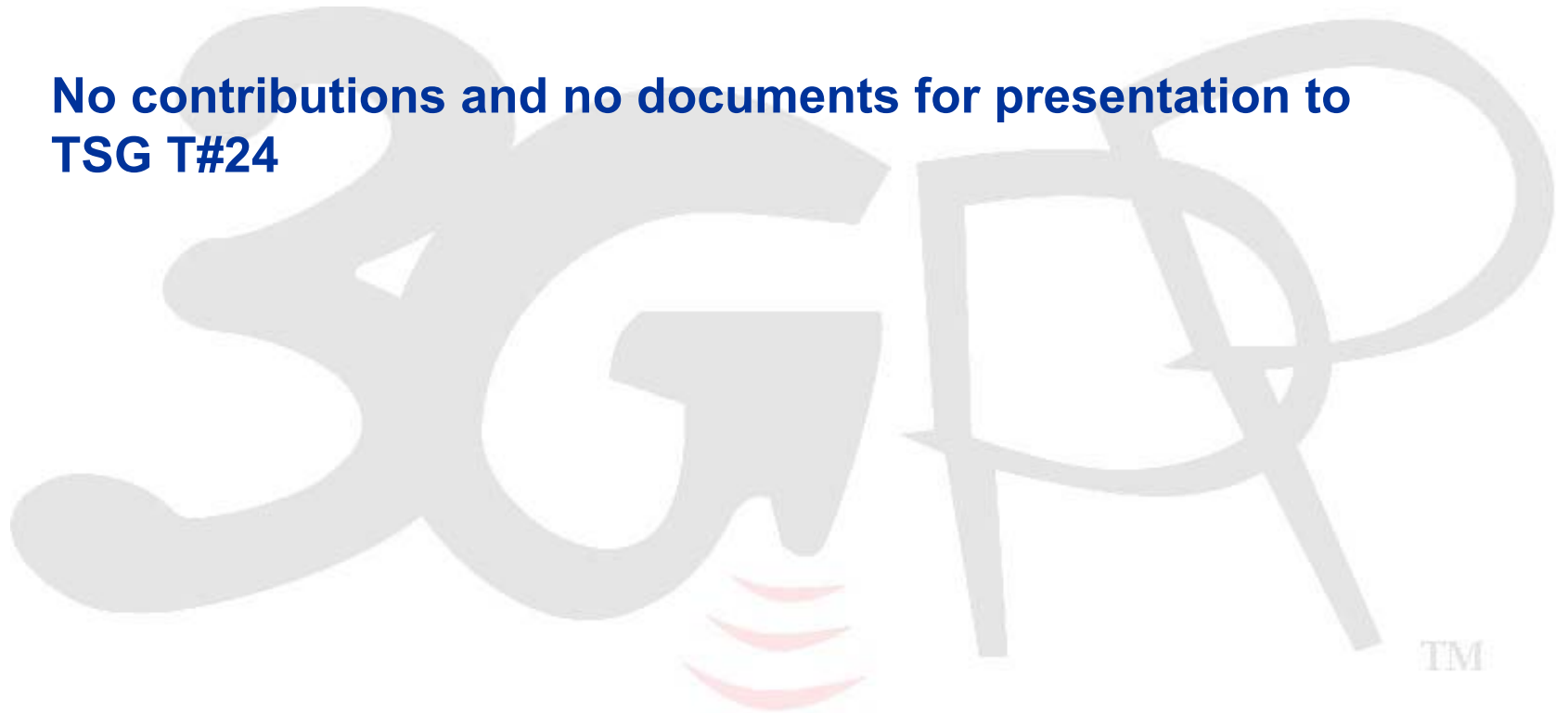
- **Private Addressing**
 - New interface proposed between MMS R/S and new Messaging Service Control Function. Areas of concern raised and noted
- **IMS Deferred Messaging**
 - Working assumptions agreed to assist future CR's. In particular, WAP implementation on MM1 to be used for user to user messaging for SIP based addressing
- **Multiple Relay/Servers**
 - General consensus that MM4 is suitable for multiple R/S within an MMSE but further analysis is required. A new annex to 23.140 might be the outcome rather than a TR as originally envisaged
- **Application ID**
 - Working assumptions produced and agreed. Two potentially controversial issues

SWG3 Ongoing matters ***(continued)***

- **MM1 enhancements**
 - Proposal for addition of status text in MM1 Delivery
- **MM4 enhancements**
 - Working assumptions on MM4 bundling endorsed
 - Support for multiple recipients (a CR has been conditionally agreed by T2 and will be automatically agreed by T2#26 (Montreal) for presentation to T#25 (Palm Springs) unless serious concerns are raised by SA5 / GSMA by then. LS sent to SA5 and GSMA)
- **MM7 enhancements**
 - Proposal to enable an MMS R/S to indicate to a VASP whether a user is roaming

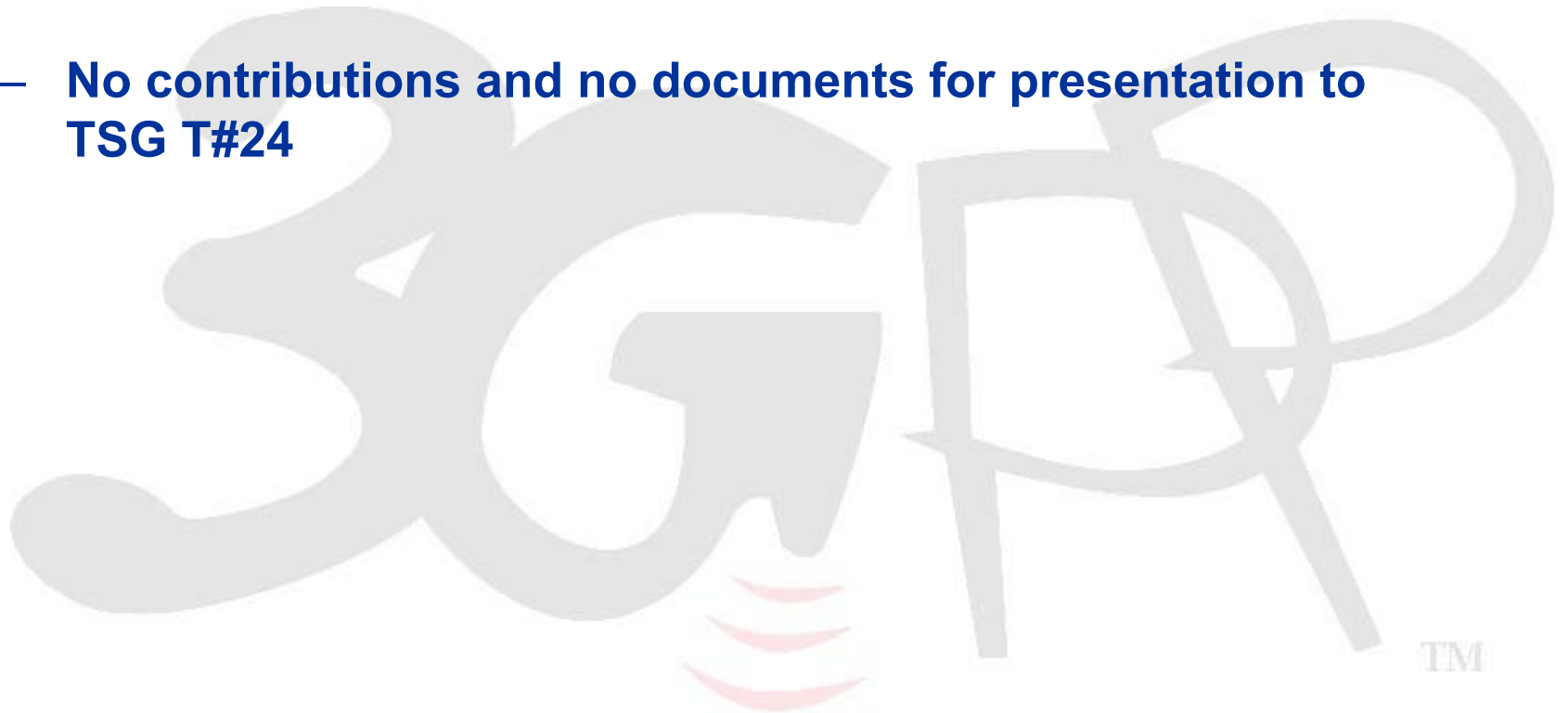


SWG3 Summary (SMS)

- **2 LS's agreed**
 - Response to CEPT/ECC document MMS/SMS/UMTS Short Codes. **Note:** Sent to TSG-T not direct to CEPT / ECC
 - 3GPP / WLAN Interworking. **Note:** This LS also relates to MMS as a secondary matter
- **2 REL- 6 CR's agreed**
 - TS 23.040 Enhanced Voice Mail Information. This CR allows voice mail systems to convey via SMS to the user enhanced information regarding voice mail messages and voice mail box status such as a list of voice messages, the time a particular voice message was left, who it was from – if known, message duration etc.
 - TS 23.040 Optional IEI clarification
