## Candidature for TSG-T3 Chairman

CV of Candidate Dr. Klaus Vedder

Klaus Vedder was educated at the universities of Tübingen, Birmingham and London, where he received his doctoral degree in Mathematics.


In 1988 he joined the international committee responsible within ISO and IEC for the standardisation of cryptographic techniques and became the editor of two International Standards on authentication techniques. From 1992 to 1996 Klaus Vedder has been the chairman of the ISO/IEC committee SC 27 "Information technology - Security techniques" the scope of which includes the standardisation of generic methods, techniques and evaluation criteria for IT Security.

Also in 1988, he joined SIMEG, the Subscriber Identity Module Expert Group, which had been established that year to specify the SIM for GSM. In 1993 Klaus Vedder became Chairman of SIMEG which was, one year later, made the ETSI committee SMG9 "SIM Aspects", the custodian of the SIM and its enhancements. Over the last years, SMG9 has, apart from the Phase 2+ enhancements to the "basic" SIM card standards, created quite a few new standards which have transformed the SIM from a security and storage device into a secure platform for value added services. These include the SIM Application Toolkit standards (GSM 11.14 and GSM 03.48) and the SIM API standards (GSM 02.19 and GSM 03.19). On the technical side, SMG9 developed the world's first 3V and 1.8V standards for the interface of a smart card and a card terminal. A SIM Conformance Test Specification was created to help operators in their procurement efforts. Within ETSI, SMG9 is now also responsible for general IC card issues and has, consequently, been renamed SMG9 "IC Card Aspects".

Klaus Vedder is Executive Vice President and Head of Telecommunications at Giesecke & Devrient (G&D) which has its main offices in Munich, Germany. G&D was established as a security printer over 140 years ago. Today G&D is a major supplier of banknotes, banknote paper and banknote processing machines as well as cards and card systems for the financial and telecommunications world. G&D and its subsidiaries form a world-wide group of companies employing 4.500 people with a turnover exceeding 1.4 billion German Marks.
