1 Introduction

Correspondence has been received from the TD-SCDMA Forum in which they request MRP status within 3GPP. This request was notified to the PCG exploder list on 11 March 2003.

The correspondence received from the TD SCDMA Forum is attached to this document, together with a set of slides which describe their work.

2 Action required by OP#9

The 3GPP Partners are requested to consider this request and to grant MRP status to the TD SCDMA Forum.

The TD SCDMA Forum had initially registered their intent to participate in this meeting, but cancelled their participation due to travel concerns.

Dear Mr. Scrase,

The TD-SCDMA Forum is an Industry representative body established for promoting the further development and promotion of the ITU IMT-2000 radio technology being standardized within 3GPP and is classified as TDD low chip rate mode. This technology is known in China as TD-SCDMA. In this context, it is clearly within our remit to assist industry in the deployment and promotion of this technology and in turn to respond to what we see as the market requirements of this 3GPP technology.

The TD-SCDMA Forum fully supports the work that has been done within 3GPP and has high admiration for the way in which the current requirements of TD-SCDMA have been understood and accommodated within your specifications. However, as we now start to look more closely at the deployment of the technology and the delivery of services to our customers, it seems more reasonable that we establish a much closer collaboration with you in order that we can assist in clarifying the market requirements of TD-SCDMA and promote the work of 3GPP. It has been proposed by WTS, the Organizational Partner in 3GPP from China, that Market Representation Partner status would be the most suitable vehicle for us to assist you and we understand that they fully support our application.

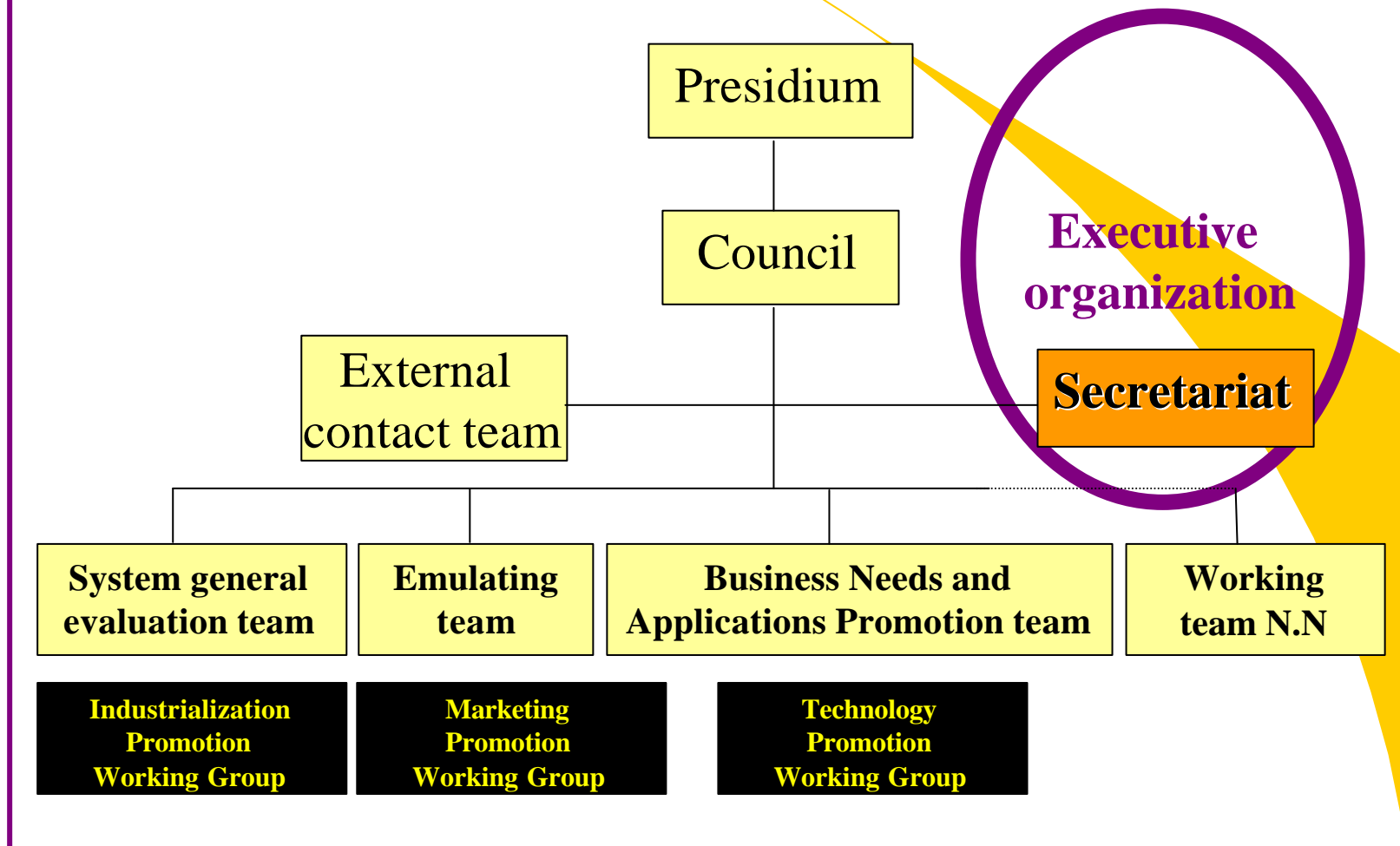

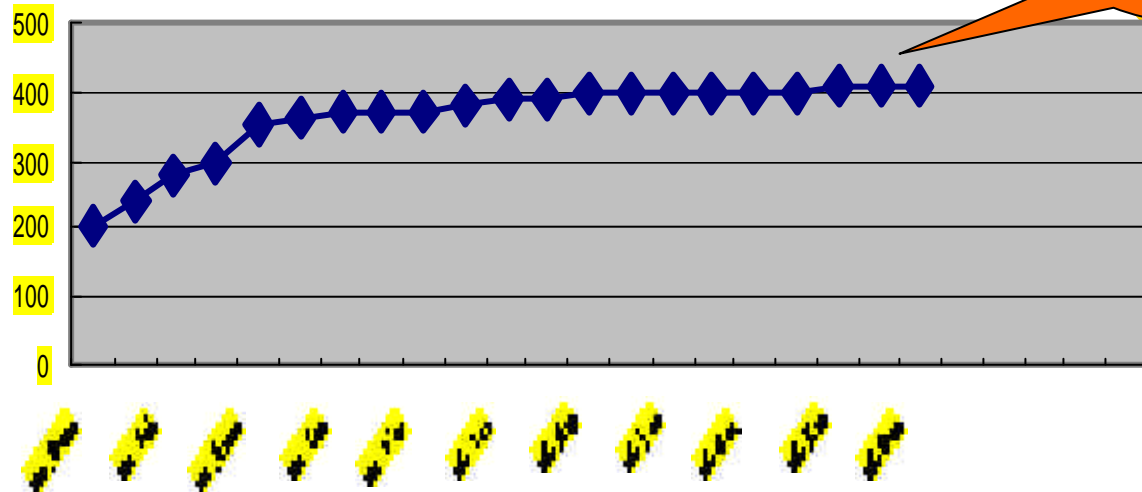
