

## Frequently Asked Questions (FAQ) January 2002 S2 #22, S1 adhoc, and CN1 SIP adhoc near Phoenix Arizona

**Q1: Will there be a social event?**

**A:** **Yes.** Your co-hosts, AT&T Wireless and Rogers Wireless, will be sponsoring a western cookout for the 3GPP delegates on the evening of Wednesday, 16 January. This is a **3GPP delegate only event**. All 3GPP delegates to the S1 adhoc, S2 #22 meeting, and the CN1 SIP adhoc are invited to attend.

**Q2: Does the \$199 per night room rate for 3GPP delegates include meals?**

**A:** **No.** However, your co-hosts, AT&T Wireless and Rogers Wireless, will be sponsoring the meals and the cost of these meals is **not** included in the nightly room rate paid by the 3GPP delegates.

**Q3: What meals are being sponsored by the co-hosts?**

**A:** Your co-hosts AT&T Wireless Services and Rogers Wireless will be sponsoring the following meals for the 3GPP delegates who are staying at the Carefree Conference Resort (see the answer to question Q6 and 7 for options for delegates who chose to stay elsewhere):

Sunday 13 January	- Dinner buffet
Monday 14 January	- Breakfast buffet - Lunch buffet or lunch barbecue by the pool - Dinner buffet
Tuesday 15 January	- Breakfast buffet - Lunch buffet or lunch barbecue by the pool - Dinner buffet
Wednesday 16 January	- Breakfast buffet - Lunch buffet or lunch barbecue by the pool - <b>Western cookout social event</b>
Thursday 17 January	- Breakfast buffet - Lunch buffet or lunch barbecue by the pool - Dinner buffet
Friday 18 January	- Breakfast buffet - Lunch buffet or lunch barbecue by the pool

Continuous breaks will be available during all meeting days including the Sunday afternoon session.

The dinner buffets are offered on a rotational basis with different selections provided for each evening. The variety of choices provided by all buffets should be able to satisfy special dietary requirements (e.g., vegetarian).

**Q4: Is there a room charge for additional guests with the 3GPP delegate?**

**A:** **No.** A delegate may have additional guests in their room. However, these guests are not entitled to the AWS and Rogers Wireless sponsored meals and continuous breaks.

However, an option is available for the delegate to pay for three meals and continuous breaks each day for an adult guest at a rate of US\$81 per day. This allows the guest access to breakfast, lunch, and dinner, as well as the continuous breaks.

Alternatively, delegates who do not wish to utilize this option can choose to pay for all of their guest's meals separately.

**Q5: What is included in the \$81 per day charge for additional guests with the 3GPP delegate?**

**A:** The \$81 per day charge for additional guests is the automatic charge by the hotel to cover the double occupancy charges and to provide the guest with access to the complete set of meals & continuous breaks.

Alternatively, delegates who do not wish to utilize this option can choose to pay for all of their guest's meals separately.

Delegates are asked to notify the AWS meeting planner, Christine Byron, **before Monday 4 January 2002**, on whether additional guests will be sharing a room and if they want to be included in the three meals per day. Delegate's guests who participate in the three meals per day option will be billed \$US81 per adult guest.

**Q6: Is there a \$60 per day charge for delegates who do not stay at the meeting hotel?**

**A:** **There is no \$60 per day charge for delegates who do not stay at the meeting hotel.** Since the meeting co-hosts, AT&T Wireless and Rogers Wireless, are sponsoring all meals for the 3GPP delegates, this daily charge for delegates who do not stay at the meeting hotel will be covered by the meeting co-hosts.

As a courtesy, the meeting co-hosts respectfully request that 3GPP delegates consider staying at the arranged meeting hotel if at all possible.

Any 3GPP delegates who elect to not stay at the Carefree Meeting Resort but wish to partake in any of the co-host sponsored meals should contact the AWS meeting planner, Christine Byron, **before Monday 4 January 2002**, so that proper arrangements with the meeting hotel can be established.
