Reason for change:	#	The first part of the first sentence in chapter 5.2.1.1 states that it shall be possible to request either IRI or both IRI and CC, which clearly means that it is not required to deliver CC only. The second part of the same sentence states “..of CC and IRI if required” and could be misunderstood as the possibility to deliver only CC, which is against the first part of the sentence
Summary of change:	#	The second part of the first sentence is rephrased to avoid contradictions inside the TS.
Consequences if not approved:	#	Wrong information and unclear requirements in the TS.

5.2.1.1 Activation of LI

As a result of the activation (of a warrant) it shall be possible to request for the specified target, either IRI, or both the IRI and the CC and designate the LEA destination addresses for the delivery of the ~~CC and~~ IRI and if required CC. These shall be selectable on a 3GMS basis according to national options.
