### **1. Introduction**

ITU-T SG11 is currently undertaking an informal meeting with 3GPPs as shown in Annex. 3GPP TSG-CN is expected to express its position with regard to cooperation with ITU-T. This document proposes a necessary work in 3GPP TSG-CN.

### **2. ITU-T Coordination Adhoc Activity**

In TSG-CN, ITU-T coordination adhoc was established to work as a bridge between 3GPP and ITU-T and to deal with high level political issue. So far, it has been assumed that the work could be proceeded by email basis. This time, 3GPP TSG-CN should submit a written paper to the proposed informal meeting. Therefore, Im currently planning to hold a face-to-face meeting tentatively as follows.

**Place: DoCoMo Europe Office in Paris**

**Expected No. of Participants: less than 25 (TSG-CN, WG Chairs and one representative from each company)**

**(2) Liaison method between 3GPP and ITU-T SG11**

**(3) Drafting the position paper**

Dear All,

Thank you for your comments, Raj, Moh and Masami on my comments as well as on the original proposal from John.

As I understood the discussions so far, the following points seem to emerge, which I would like to propose as my revised proposal.

1. There should be an informal meeting among ITU-T SG 11, 3GPP and 3GPP2 key leaders on IMT-2000 Network aspects (ITU terminology) or 3G Core Network aspects (3GPP terminology).

Note: Thus, the "Seminar" originally proposed by John is proposed to be replaced by this informal meeting.

2. The objectives are:

- To exchange information on current work plans of ITU-T SG11, 3GPP and 3GPP2 on IMT-2000 and beyond with regard to (core) network aspects, and on how each views others' roles in their respective work plans.
- To reach some consensus on the cooperation among the three bodies, contents-wise as much as possible and, at least, procedure-wise, and to propose it to higher management levels of each body.

4. Proposed agenda

4.1 Information exchange:

Status report from ITU-T SG11:

- (Draft) Recommendations decided/to be decided before and in June 2000, including draft Q.1701 Supplement
- Work plan of SG 11 in year 2000 (common NNI and mobility management protocols)
- Draft Questions proposed for study after WTSA 2000
- Results and work plans relevant to IP networks (i.e. BICC, AAL2, H.323 interworking, etc) for information to 3GPP in their further work on 3G all-IP networks.

Status report from 3GPP: details to be supplied by 3GPP

Status report from 3GPP2: details to be supplied by 3GPP2

## 4.2 Consensus making

- ITU-SG 11's expectations on the roles of itself and of 3GPPs concerning (core) network aspects
- Expectations of 3GPP's TSG-CN towards ITU-T SG11 on (core) network aspects
- Expectation of 3GPP2's network group towards ITU-T SG11 on (core) network aspects
- Reconfirmation of agreement(?) in the previous GSC adhoc meeting (May 1998)
- liaison method between 3GPPs TSG-CN, 3GPP2's network group and ITU-T SG11
- several outstanding technical matters, e.g., NNI standardization

## 5. Proposed time schedule

- (1) ITU-T SG11 will send an invitation with clear agenda and objectives of this informal meeting to 3GPPs TSG-CN and 3GPP2's equivalent group as soon as possible (3rd week of March).
- (2) ITU-T SG 11, 3GPP TSG-CN and 3GPP2's equivalent group will prepare their position papers for each agenda item by middle of June.
- (3) The unofficial meeting will be held in early July and results will be reported to higher executives in ITU and in 3GPPs.
- (4) Higher level dialogues will be started between ITU and 3GPPs in July-August 2000.

Note 1: The need for further meeting(s) depends on the outcomes of each step described above.
