In line with the procedure contained in RP-020836 (see relevant time schedule attached for your convenience), ITU-R Ad Hoc was able to draft all input contributions for the Final submission toward Revision 4 of Recommendation ITU-R M.1457 (following discussion at the last RAN Plenary and subsequent guidance from RAN Chairman it was determined that no face-to-face meeting nor conference call of ITU-R Ad Hoc was needed to finalize the material). All docs are submitted to RAN for approval and subsequent submission to ITU-R WP 8F via Individual Members, as usual. It is clarified that the deadline for the submission of any input related to Rev. 4 of M.1457 to the next meeting of ITU-R WP8F (Edinburgh, 8th –16th October 2003) is October, 1st. Any other input contribution to the next meeting of ITU-R WP8F must be received by ITU by September, 24th.

In particular, the following docs are submitted to RAN Plenary for approval:

- ?? RP-030432 – Update list of Specs (titles and synopsis) in Sections 5.3.2 of Rec. M.1457;
- ?? RP-030433 – Proposed accompanying letter for the submission of the updated Global Core Specifications (GCS that has to be prepared by 3GPP Secretary based on the outcome of the current TSGs Plenaries).

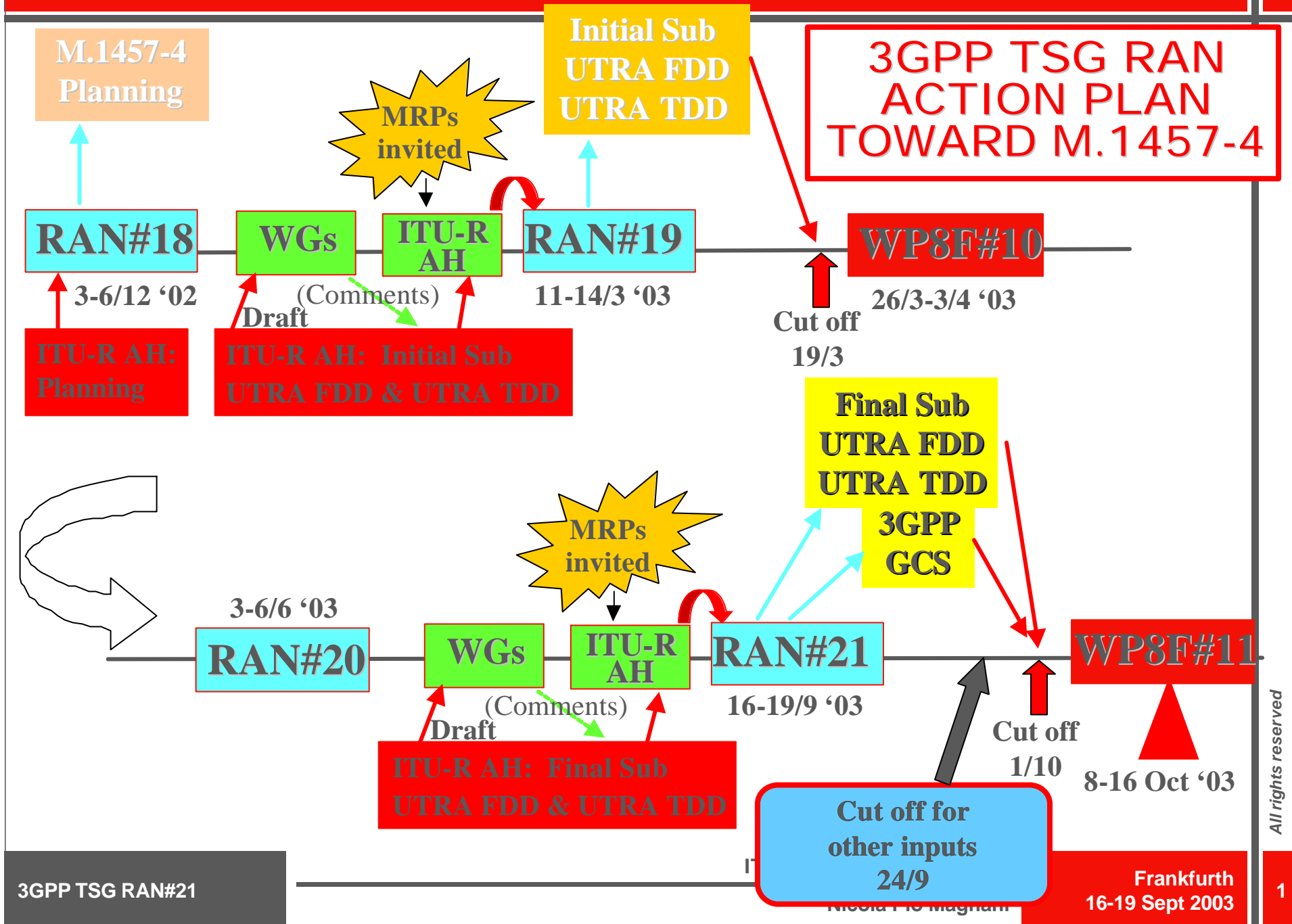
In addition the following docs were prepared by ITU-R Ad Hoc:

- ?? RP-030436 – Proposed updated information on the Roadmap (to be submitted to ITU-R WP8F via Individual Members by September, 24th).

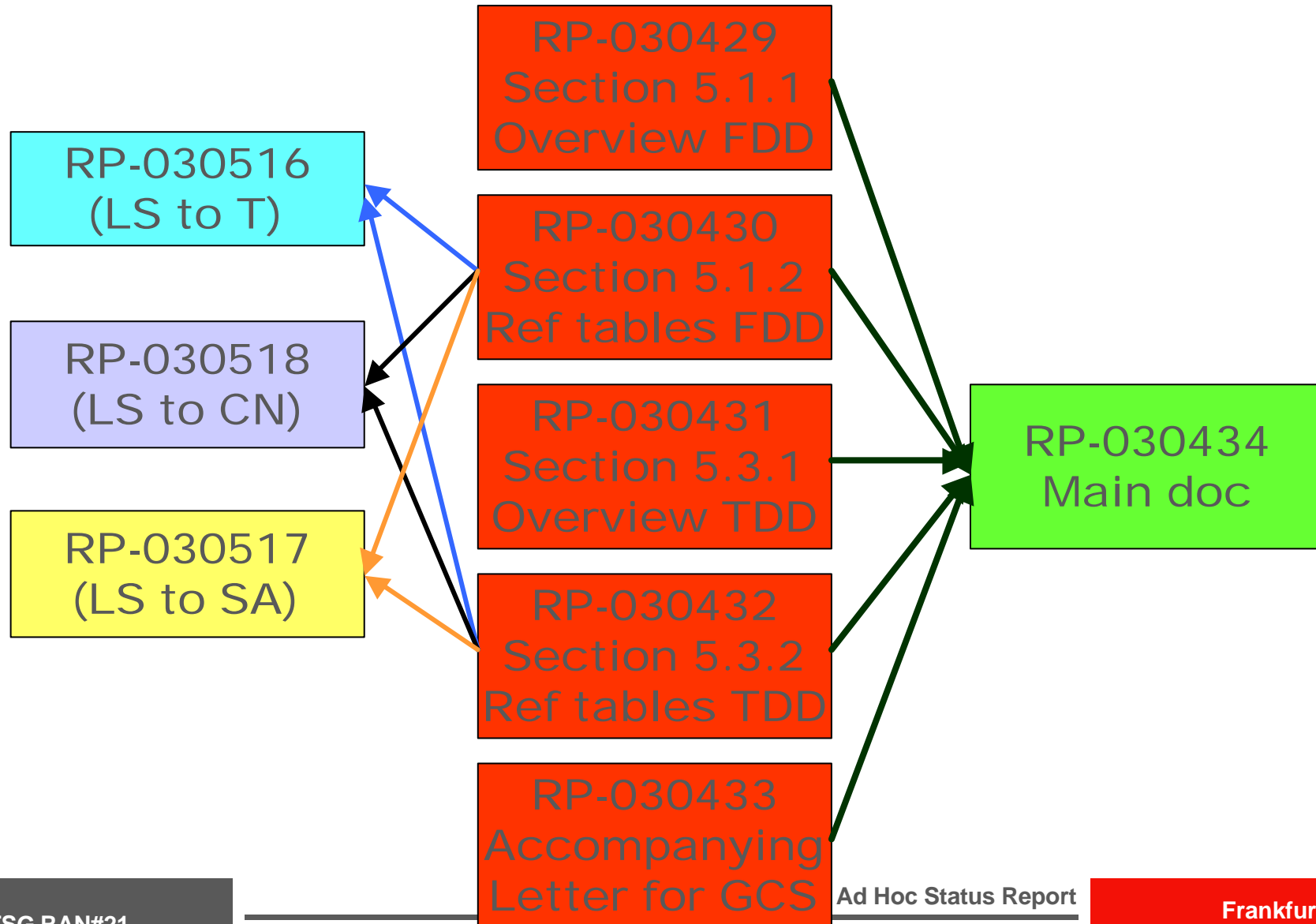
Following discussion at RAN#17 on how to submit to ITU the outcome of the Study Item on the viable deployment of UTRA in additional and diverse spectrum arrangements, ITU-R Ad Hoc discussed the issue by correspondence but it was not possible to reach a conclusion due to lack of time. RP-030511 tries to capture the outcome of the discussion: it is up to RAN to decide how to proceed. Any possible

input to the next meeting of ITU-R WP8F on this topic has to be submitted to ITU via Individual Members by September, 24th.

Finally, with reference to the working document prepared by ITU-R WP8F towards a preliminary draft new Report on mitigating techniques that will be finalised at the next meeting of ITU-R WP 8F, the issue was discussed at the last RAN4 meeting. Any possible input to the next meeting of ITU-R WP8F on this topic has to be submitted to ITU via Individual Members by September, 24th.
